- 8. To approve MSc Botany in (Angiosperms and Pharmacognosy) syllabus from AY 2023-24.

The meeting was hosted by Ms Nupoor Telawane of the Department of Botany followed by Prof. (Dr.) Ajit Kengar, Head of the Department, Botany welcomed the BOS Members. The minutes of the last BOS of the AY 2021-22 were presented by Dr. Rajani Shirsat. The agenda was shared with BOS Members. The minutes and action taken report were shared with BOS Members.

The following points were discussed in the meeting:

- The briefing for the S.Y. B.Sc. and T.Y. B.Sc. the curriculum of AY 2023-24 was done by Dr. Supriya Thale, updated with the previous BOS suggestions and the modifications are included in the syllabus. It was discussed and approved unanimously by all BOS members.
- The discussion on syllabi As Per NEP 2023 for Discipline-specific courses, will be finalised soon on receiving the guidance from the Government of Maharashtra and UGC guidelines For the Syllabi for the Discipline-Specific Courses (DSCs), Skill Enhancement Courses (SECs) and General Electives (GEs) that could be offered to FY classes under NEP approved.
- 3. The Curriculum for M.Sc. (Specialization: Cytogenetic, Molecular Biology and Plant

Biotechnology) were approved with the changes for shifting of Syllabus from Semester II to Semester I and vice versa (mainly for Plant Physiology). The necessity of shifting the syllabus was to correlate the practicals with the Theory.

- 4. The Outline of the M.Sc. specialization for Angiosperm Taxonomy and Pharmacognosy was presented For the Next academic year 2024-25 and the syllabus will be shared with the BOS members.
- 5. The current Paper pattern and marking scheme of the M.Sc. were presented by Prof. (Dr.) Ajit Kengar. The Paper Pattern for M.Sc. Theory Exams was discussed with the marks distribution.
- 6. The suggestion given by Dr. Sardesai for the implementation of new marks distribution pattern for question papers was noted. He suggested improving the paper pattern. The Paper pattern should include Long Answers, Short answers and very short answers. The other BOS member agreed to the paper pattern and marking scheme.
- 7. The Paper pattern with the marking distribution suggested by Dr. Desai was as follows:
 - Q.1. 10 Marks (Any 5 out of 6 will be for 2 Marks)
 - Q.2 Short notes (Any 2 out of 3 will be 10 marks Each)
 - Q.3 Short notes (Any 2 out of 3 will be 10 marks Each)
 - Q.4 Short notes (Any 2 out of 3 will be 10 marks Each)
 - Q.5 Short notes (Any 2 out of 3 will be 10 marks Each)
 - Q.6 Short notes (Any 1 out of 4 will be 10 marks Each)
- 8. The discussion also included the implementation of the National Education Policy 2023 (NEP). In Karnataka State, the NEP has been implemented and is being conducted smoothly by Dr. Desai

Sir. State wise changes are expected while implementing the NEP 2023. The suggestions were invited for Discipline-Specific Courses (DSCs), Discipline-Specific Electives, Skill Enhancement Courses (SECs) (if applicable) and General Electives (GEs) (if applicable) that the department can offer in S.Y.B.Sc. and T.Y. B.Sc. once NEP is implemented for those levels of the degree programme.

The Meeting was concluded with suggestions to be mailed if any. Dr. Supriya Thale proposed a vote of thanks.

Minutes of the Meeting

1. The Meeting of Board of Studies commenced from 3:00 pm in the

Department of Zoology. The Head of the Department of Zoology and Syllabus Committee Chairman, Dr. Vinod R. Ragade addressed and welcomed Dr. B. B. Sharma, I/C Secretary, Kelkar Education Trust, KET's V.G. Vaze Autonomous College, members of the Board of Studies and faculty members of Department of Zoology. The briefing about the contribution of the members of Board of Studies and the summary of the discussions pertaining the previous Board of Studies 2022-23 were put forward.

- 2. Dr. Vinod R. Ragade had started with the presentation and mentioned about the agenda of the Second Board of Studies.
- 3. Dr. Vinod R. Ragade explained in a synchronised manner with successfully implementation of the syllabus of 2022-23 as approved by the members of Board of Studies.
- 4. The NEP outlines were summarized with the probable topics for FY, SY and TY Classes to be opted for Non-NEP Courses.
- Dr. Vinod R. Ragade explained the evaluation pattern of question paper pattern of 60-40 Assessment of FYBSc, SYBSc, TYBSc, MSc-I and M.Sc-II Examination for the academic year 2022-23.
- 6. Dr. Vinod R. Ragade had mentioned about the Course Outcomes (COs)
- and align them with Bloom's Taxonomy levels and

Programme Specific Outcomes (PSOs) of the syllabus.

- 7. The FYBSc syllabus requests no changes. The addition and modification of some topics were done in SYBSc syllabus. The modification in the topics of Classical Taxonomy, Immunology, and changes in performing practical was inculcated. The addition in practical was done in M.Sc-I Syllabus. The topics in M.Sc. syllabus are marked for Presentation, allotted for Internal Assessment.
- 8. The addition of the theory and practical topic were put forward by replacing some topics due to its repetition. The Research project proposal is allotted for 40 marks as Internal Assessment for M.Sc-II Semester IV Animal Physiology and Oceanography Paper IV with schematic marks distribution for each criteria.
- 9. The marking scheme for Visit to Pathology Laboratory for 10 marks were allotted for Semester III Animal Physiology Practica-3. The Report to national park/ sanctuary were allotted for 10 marks in Semester IV Animal Physiology Practical-2. The report of Visit to Intertidal Zones/ National Part/ Sanctuaries/local fish markets/ fish landing centre was allotted for 5 marks in Semester IV Oceanography Practical I. Two performing practicals are added in Semester IV Oceanography Practical-3.
- 10. Dr. Sudesh Rathod, Vice Chancellor's Nominee appreciated the successful implementation of Autonomy syllabus with the changes suggested in the academic year 2022-23.Dr. Sudesh Rathod approved the changes, internal assessment pattern, question evaluation pattern for FYBSc, SYBSc, TYBSc, MSc-I and MSc-II. Dr. Sudesh Rathod suggested that the NEP must be implemented only if the directives and framed syllabus criteria as are clarified.
- 11. Prof. Dr. R.S. Pandit approved the syllabus with the changes and internal assessment, question pattern for FYBSc, SYBSc, TYBSc, MSc-I and MSc-II. Prof. Dr. R.S. Pandit has mentioned that the guidelines of NEP will be notified and further implementation of NEP can be inculcated accordingly. The syllabus modification of FY, SY and TY should be modified from simpler level to complex level in accordance with the Bloom's Taxonomy. The Classical Zoology topics should be correlated with Genetic level and molecular level characteristics of species. Eg. DNA Barcoding with justification.
- 12. Dr. Sudesh Rathod suggested that there must be more need for expertise in the Taxonomical aspects of Zoology with more specifications at molecular level in the syllabus.
- 13. Dr. Ramesh M. Gejage appreciated the successful completion of the syllabus in 2022-23. Dr. Ramesh M. Gejage approved the changes, internal assessment, and question pattern for FYBSc, SYBSc, TYBSc, MSc-I and MSc-II. Dr.Gejage suggested that the NEP Policy must be justified with mode of interest and subjects which has to be studentcentric.
- 14. Mr. Robin Mathew suggested that if the NEP is implemented, the subject of Zoology can be opted as an optional subject for Civil Services gaining as a weightage for the subject.

- 15. Mr. Kuldeep Mhatre suggested that the topics can be modified in accordance with the entrance exams such as SET, CSIR UGC NET, JRF, ICAR, GATE, UPSC, etc. to highlight career options in Zoology.
- 16. Mr. Robin Mathew appreciated the introduction of Pathology laboratory visit, which will give the exposure of techniques and jobs in Pathology. Mr. Robin Mathew suggested that the introduction of skill-based courses, which are career oriented for competitive exams and designing the same would be noteworthy.
- 17. Dr. Kiran R. Kharat have shared the experience of NEP implementation and the syllabus can be innovatively modified according to the NEP with FY, SY and TY level with student-centric approach.
- Dr. B.B. Sharma has shared the inputs on the successful outcomes of the syllabus approved for 18. the academic year 2022-23. Dr. B.B. Sharma had put forward the expertise opinion of NEP validation and justification. Dr. B.B. Sharma have suggested to forward the updated syllabus of FY, SY, TY, MSc-I and M.Sc-II to confirm the approved changes in the syllabus.
- 19. Dr. S. S Barve suggested that the syllabus changes are good. The Non-NEP Courses should include the topics under FY, SY and TY level with a shuffling of topics in accordance with the complexity of the subjects. Dr. S. S Barve suggested that the research-oriented concepts and advancement is to be highlighted when NEP is put forward in FYBSc syllabus and the research aspects to be inculcated in the syllabus needs more validation.

All the members of BOS approved the proposal.

- 20. The Head of the Department of Zoology, Dr. Vinod R. Ragade concluded the meeting of Board of Studies by mentioning the tradition of Zoology of V. G. Vaze Autonomous College and appreciated the efforts of all the members and staff members of Zoology.
- Dr. Vinod R. Ragade extended vote of thanks to every member of Board of Studies for their 21. valuable time, suggestions, contribution, and efforts towards the implementation of the syllabus of Zoology of V. G. Vaze Autonomous College for the academic year 2023-24.
