- ➤ Students who have passed H.S.C Examination from V.G. Vaze College (Autonomous), Mulund East, Mumbai- 400 081, and wish to apply for admission to FYBA/FYBSC/ FYBCOM courses are required to fill the Admission Form available on our College Website-https://cimsstudentnewui.mastersofterp.in/
- ➤ Regular Students of this College, who were studying in SYJC Arts/ SYJC Science/SYJC Commerce during the Academic Year 2024-2025 and have passed the H.S.C. Board Examination, are eligible for admission as in-house students only in their respective streams i.e., B.A/B.SC/B.COM.

PLEASE NOTE:-

- Students are required to adhere to the schedule given in this notice and there will be no further extension of admission dates for Vaze college in-house students
- > Entire admission process will be held in an online mode. Offline forms will not be accepted for any course admission.
- Online applications for admission to Aided courses of FYBA/FYBSC/FYBCOM will be considered for the in-house quota.
- ➤ Students interested in Self Financing Courses Admissions are required to apply separately for the concerned SFC courses and not through the In -house Aided courses admission forms. All the SFC courses admissions will be held under Outside admission process.
- ➤ Students filling Subject Preference for FYBA must note that there is NO GUARANTEE that they will be necessarily allotted the subjects of their choice. Subject allocation will be done during the physical verification of documents of the student after his/her name features in the merit list.

- **4.** Students who have passed the HSC Examination in March-2025 against Form No-17 from Vaze College, having gap should apply in physical mode on College Office Counters till the dates mentioned in the Admission Schedule.
- **5.** Students who have passed the HSC Examination **Prior to March-2025** from Vaze College, having gap should apply in physical mode on College Office Counters till the dates mentioned in the Admission schedule.
- **6.** After filling the form, students have to download it on the mobile phone or PC or laptop. **They also need to take a print- out of the form.**

For admission to V.G.Vaze College (Autonomous), Mulund you will have to fill the college online application form from the College website, in addition to the University Pre-Registration form.

Separate application forms have to be submitted for each of the different programs you are seeking admission into e.g an application for B.Sc program does not entitle a consideration for B.A or any other program.

NOTE ON MINIMUM ATTENDANCE REQUIREMENTS-:

As per Ordinance of University of Mumbai 0.6086 dated 05/05/2014, 75% attendance at Lectures/Practicals is mandatory. Students joining this College are required to read and accept the provisions of the rules under Autonomy specially related to Attendance.
